- Acted as member of a team of lawyers acting for Russian bank as Defendants/Respondents in a major dispute regarding a fraud claim including freezing of assets and disclosure of assets worth €202 million. Case was dismissed.
- Acted as member of a team of lawyers acting for a Cypriot Company of Russian interests in a major dispute with a Russian Bank involving claims totalling \$2 billion as well as highly contentious and complex interim proceedings pertaining to Norwich Pharmacal (Disclosure) Orders and Gagging Orders. Filing of a lawsuit on behalf of the client against, inter alia, the debtor, the pledgor, the Bank, the Interim Receiver, seeking, inter alia, declarations that the share pledge is valid, compensation for the debt and recovery of the proceeds from the sale of the property in Germany owned by the company whose shares were pledged for the benefit of the client.
